

Most Respectfully Sheweth:



1. That complainant is a law abiding and peace loving citizen of India.
2. That the present complaint is being filed regarding illegal interference by Bihar Cricket Association ~~respondent no.-1~~ during the pendency of a complaint already sub-judice before this Hon'ble Ombudsman (Case No.-21/2025).
3. That a complaint was earlier filed one affidavit on 09-12-2025 in Case No.-21/2025 by Abhishek Kumar, Treasurer, Motihari (East Champaran) District Cricket Association, which is still pending before this Hon'ble Court.
4. That during the pendency period of the aforesaid case, Bihar Cricket Association, on 29-11-25, convened a Committee of Management meeting and, while taking cognizance of an email sent by Ravi Raj, who claims himself to be Secretary elected through a forged and fabricated election, referred the matter of imposing an Ad-Hoc Committee in East Champaran District Cricket Association to a committee headed by Shri Vipul Sinha, Retired ADJ, which action is wholly illegal and ~~contrary to the Constitution of Bihar Cricket Association.~~

5. That the Constitution of Bihar Cricket Association does not confer any authority upon BCA to interfere in the affairs of any District Cricket




Association, as all affiliated District Associations/full members have their own General Body, which alone is empowered to take every decision in accordance with the Constitution applicable to the concerned District Association.

6. That the committee headed by Shri Vipul Sinha allegedly constituted an Ad-Hoc Committee for East Champaran District Cricket Association on 17-12-2025, which is illegal, arbitrary and void ab initio, as upon personal communication with Shri Vipul Sinha, it was revealed that he had no knowledge whatsoever about such meeting.

7. That the true facts are that under the garb of the committee headed by Shri Vipul Sinha, on the directions of Shri Rakesh Kumar Tiwari, the General Manager (Administration) of BCA, Shri Neeraj Singh, has been unlawfully constituting Ad-Hoc Committees in various District Associations for the last several years, which practice is unconstitutional, arbitrary and against the principles of transparency and fair administration.

8. That BCA had already taken East champaran District as agenda in its meeting dated 29-11-2025 and thereafter proceeded to pass decisions despite the pendency of the present case.

9. That thereafter, on 19-01-2026, BCA illegally constituted an Ad-Hoc Committee in Motihari District Cricket Association, which is arbitrary and illegal. Annexure is annexed with this petition .



10. That the aforesaid actions of Bihar Cricket Association amount to interference with judicial proceedings and are liable to be stayed.

It is therefore prayed that this Hon'ble Ombudsman may be pleased to restrain BCA from interfering in the affairs of Motihari District Cricket Association and Stay the Ad-Hoc Committee constituted on 19-01-2026 and Direct removal of related notifications from BCA website.






